MEMBERSHIP FEE INFORMATION

Not-For-Profit Elgin Junior Chamber

The mission of the Junior Chamber organization is "To contribute to the advancement of the global community by providing the opportunity for young people to develop the leadership skills, social responsibility, fellowship, and entrepreneurship necessary to create positive change."

Regular Not-For-Profit Membership in the Elgin Junior Chamber (hereafter referred to as the Organization) is open to all men and women between the ages of 18 and 40, as well as employees of non-for-profit corporations which are actively engaged with the ELGIN JAYCEES. In addition, regular membership entitles membership into the Illinois Jaycees, United States Jaycees and Junior Chamber International.

Associate members are entitled to all of the benefits of membership of the Organization, except that they hold no voting privileges in the Organization and may not serve on its Board of Directors.

Not-For-Profit members have the option of choosing Regular Membership in the Organization.

Membership in the Organization is considered a year-to-year commitment. A member will be responsible for the full payment of annual dues at time of new membership. Renewal dues are to be paid within the 30 day period ending with the member's anniversary date.

FEE STRUCTURE

Core Dues

Dues of the Organization cover the cost of "core" functions that benefit all members. The annual budget and appropriate dues rates are recommended by the Board of Directors of the Organization and approved by the membership at each year's Annual Meeting.

COMPUTATION & COLLECTION OF MEMBERSHIP FEES

Reporting Revenues

For the computation of the Organization's dues, the Membership Development Vice President and the Treasurer shall report all dues revenue in a financial statement.

Billing Procedures

All member dues shall be payable upon new enrollment or within 30 days before the member's anniversary date. If member is unable to pay in full their dues, a written statement shall be submitted to the Board stating reason for non-payment or to ask for a payment plan.
